REQUISITE DOCUMENTS FOR FAMILY REUNION VISA FOR DEPENDENT PARENTS.

| 1. | Visa application form fully completed and signed by the applicant. | | |
| 2. | Two recent passport-size photographs (white background). Please do not staple the photographs to the application form. | | |
| 3. | Passport issued within previous 10 years and the validity must not exceed 10 years. Passport should have least 3 months after intended stay. Passport must have 2 blank pages. Passport must be issued within the jurisdiction of the embassy/consulate*. | | |
| 4. | "Nulla Osta" (No Objection Certificate) in original, issued by competent Questura in Italy. Kindly note that the "Nulla Osta" is valid only for a period up to six months from date of issue. The "Nulla Osta" will have to be renewed on expiry. | | |
| 5. | Discrepancy, if any, in the details of the applicant on the "Nulla Osta" should be corrected to correspond with the passport. If not done, the embassy will request the correction from the competent authorities in Italy. | | |
| 6. | Original attested copy of the passport (all pages) of the person who has applied for the "Nulla Osta" in Italy. If available, also of the old passport. | | |
| 7. | Original attested copy of "Permesso di soggiorno" (Permit of stay), If stay permit is expired and under renewal then copy of the renewal receipt must be also attested. | | |
| 8. | Original and English translation of Ration Card and other relevant documentation to attested by the local authorities and then duly apostilled by the Ministry of External Affairs, Govt. of India. | | |
| 9. | Original Birth certificate of the son/ daughter in Italy, issued by the registrar of births and deaths, clearly mentioning the registration number along with the translation in English language. The document has to be attested by the local authorities and duly apostilled by the Ministry of External Affairs, Govt. of India. | | |
| 10. | Affidavit from parents stating the name of all the children (even if not living together). Their date of birth and current residential status in Indian and Abroad. | | |
| 11. | A parent is considered dependent on the son/daughter in Italy when he/she does not receive any income in India and does not have other children in India. Even if he/she receives minimum pension, he/she must provide proof of having received some remittance of money for a reasonable period of time from the family member in Italy. Kindly provide original bank account passbook of the applicant/s and remittance certificates from Italy (mandatory) and India. Official documents should also be submitted in case the parent/s own property in India and are receiving any income thereof. | | |
| 12. | One set photocopy of the applicant's passport. | | |

PLEASE NOTE: All documents must be submitted in original. Documents such as Birth & Marriage Certificates, School Leaving Certificates must be submitted in original and photocopy. Photocopies to be done ONLY after documents are attested by the local authorities and duly apostilled by the MEA, Govt. of India. The above mentioned originals (Ration card, Birth, Marriage, Death, School Leaving Certificates, etc) will be RETURNED after the visa processing.

The Embassy/Consulate reserves the right to request for further documentation and to verify the documentation submitted. In this case the maximum period of 90 days fixed by the Italian law for the evaluation of this visa type will be suspended till verification is completed.

* If any change has occurred in this regard an adequate proof of residence needs to be submitted (Bank account, telephone/electricity bill etc.)
