2.	Two recent passport-size photographs (white background). Please		
	do not staple the photographs to the application form		
3.	Passport/Travel Document must:		
	a) Have been issued within the previous 10 years and the validity		
	must not exceed 10 yrs		
	b) At least have a validity of 3 months after intended stay.		
	c) Have 2 Blank Pages		
4.	For a "familiare al seguito" visa the application for the work/study		
	visa and the accompanying family visa must be made		
	simultaneously.		
5.	A "Delega" (click here) must be signed before this Consulate		
	General to nominate a person in Italy to apply for and obtain the		
	"Nulla Osta per familiare al seguito" on behalf of the principal		
	applicant. The person to be nominated for the "delega"		
	should be someone in Italy e.g. the sponsor who can apply on		
	behalf of the principal applicant to the competent "Questura" for		
6.	the "Nulla Osta al familiare al seguito". A declaration (dichiarazione per familiare al seguito) must be		
0.	made in front of the ConsulateGeneral, with a copy of the identity		
	document, requesting the presence of the spouse and minor		
	child/children in Italy and which attests that they shall be		
	economically dependent on the principal applicant. The requisite		
	documentation will be provided by this Consular office.		
	accompanying spouse/minor children) in original, issued by		
	the competent Questura in Italy. Kindly note that the "Nulla Osta"		
	is valid only for a period up to 6 months from the date of issue.		
	The Nulla Osta will have to be renewed on expiry.		
	_ Discrepancy, if any, in the names of the applicant/s on the		
	"Nulla Osta" and the passport/s, should be corrected to correspond		
	with the name on the passport.		
	_ Photocopy of the passport of the principal applicant who will		
	work/study in Italy.		
	_ Airline reservation printout to be completed later with a		
	confirmed airline ticket prior to retrieval of the visa.		

7.	For Accompanying Spouse in Italy	
	_ Original Marriage Certificate issued by the Registrar of	
	Marriage, Sub-Registrar or Gram Panchayat, clearly mentioning	
	the registration number	
8. For Accompanying Parent in Italy		
	_ Birth Certificate of the child/children in original, issued by the	
	Registrar of Births and Deaths, clearly mentioning the registration	
	number.	
9.	Legalisation of all Certificates/Affidavits in Original.	
10.	Photocopy of all observations in the passport	
11.	_ Original certificates and affidavits to be duly validated by the	
	Under Secretary of the Home Department of the	
	relevant/competent State Government. This Certificate should be	
	translated into the Italian language by a recognized translator. The	
	certificate and the translation should be legalized by the Consular	
	section of this Consulate General.	

Kindly note that the legalization of civil certificates/affidavits is no longer required from the Ministry of External Affairs, New Delhi.

The Embassy/Consulate reserves the right to request for further documentation and to verify the documentation submitted. In this case the maximum period of 90 days fixed by the Italian law for the evaluation of this visa type will be suspended till verification is completed.
